DESCRIPTION OF THE ANIMAL



1. Should the placing be unsuccessful, I undertake to return the animal to the care of CASA
2. I will give the animal a fair chance to adjust to his/her new home.
3. The animal may not under any circumstance be re-homed without prior written notification to CASA in which event CASA will handle the adoption process and a new contract will be signed after a property check had been done.
4. Should the animal expire I agree to advise CASA of this within 3 days of the death of the animal and will provide proof from the vet.
5. I confirm that the animal will sleep indoors at night and will be treated with love, affection and respect.
6. CASA will not be held liable for any injury or damage caused by the adopted animal, whether to humans or other animals/pets/domestic workers/gardeners or any person or animal that enters or resides at the adopters' premises
7. I can afford and will provide the animal with the necessary veterinary care if and when needed.
8. I undertake to keep annual vaccinations up to date.
9. I undertake not to chain or cage the animal, or allow him/her to be used as a guard dog on commercial or industrial premises, and understand that the animal will immediately be repossessed should this condition be contravened.
10. I undertake to keep the animal well fed, and in healthy condition at all times.
11. I will provide and maintain weather-proof accommodation of suitable size.
12. I will ensure that my property is securely enclosed for the safety of the animal, and undertake that I shall not knowingly allow the animal to roam the streets.
13. I understand that CASA or any person authorised by CASA may at any time visit my property to ensure that the above conditions are complied with.
14. I agree to give CASA notice if I am moving to a new property and am willing to advise the new address and allow for CASA to conduct a property inspection on the new property.



15. Should the animal be younger than 6 months of age on adoption, I undertake to comply with the STERILISATION of the animal at the age of 6 months and agree to comply with the 7 days notice period given to me by CASA when sterilisation is needed. Should the animal be too unhealthy or undernourished and sterilisation before adoption is not possible, I do comply that I will have the animal sterilised once the animal is healthy enough to do so and will comply within 7 days if CASA requests the sterilisation to be done.
16. No tail docking, ear clipping, declawing or removal / cutting of vocal cords will be allowed of any animal re-homed by CASA.
17. Should the animal at any time be found in a condition which is deemed in contravention of any of the above, a representative appointed by CASA personally may remove the animal(s) at any time.

18. I undertake to settle the entire flight cost to CASA no less than 14 days after arrival date of adopted Chihuahua.
